Investment structure is based on the number of 8" cavity units @ \$450.50 per unit with a maximum of 15 cavities (3 cavities, \$1,351.50; 6 cavities, \$2,703.00 cavities, 9 cavities \$4,054.50 with a maximum of \$6,757.50 per year for 15 cavities or more.) A manufacturer of concrete products, other than block, and located within the state of Pennsylvania, will invest \$1,351.50 per year.

**ASSOCIATE MEMBERSHIP** - Shall be open to manufacturers of equipment, aggregate, admixtures, cement, cement paint or other manufacturers or companies who sell products or provide services used by producer members such as attorneys, accountants, etc... The investment will be \$1,359.50 per year.

**OUT-OF-STATE PRODUCER MEMBERSHIP** - Shall be open to firms, individuals and corporations not located within the state of Pennsylvania and engaged in the manufacture of concrete masonry units. The investment will be \$2,000 per year.
